**CityWide Drugs Crisis Campaign** is a national network of community activists and community organisations that are involved in responding to Ireland's drugs crisis. Set up in 1995 by the Inner City Organisations Network (ICON), to bring together Dublin communities that were struggling with the heroin crisis, we now work nationally linking communities across the country dealing with a range of substance issues.

We work to promote and support a community development approach to the drugs problem - this means involving the people who are most affected by the problem in dealing with the problem - drug users, their families and communities.

Citywide is a company limited by guarantee. Our board of directors come from the community, voluntary, statutory and private sectors.

## Supporting Community Involvement in the National Drugs Strategy

## Drug & Alcohol Task Force (DATF) Community Reps

CityWide facilitates the Taskforce Community Representatives Network by bringing people together to support each other, exchange information and to identify key policy issues and develop responses. The network meets a number of times each year to discuss issues specific to the role of community reps.



#### Network of DATF Community Reps

A General meeting of DATF Community Reps took place in June. Updates were provided on a range of topics and the main discussion focused on a review of the first two years of implementing RHSR.

An end of year Networks meeting took place on Dec 12<sup>th</sup> to update on policy issues. It also included inputs on some key pieces of work over the past 12 months: Stigma training, survey/research on crack cocaine, Community Impact Assessment Tool, Health Diversion Programme.

#### Community reps in their own DATF areas

From Jan to Dec meetings were held with Community Reps in the following Task Force areas: **RDATFs:** Midlands, South East, North West, Western, North East, South Western, East Coast **LDATFs:** Clondalkin, Ballymun, SIC, Blanchardstown, Cork, NIC, Dublin North East, Canals

A consultation process has been initiated into the arrangements for representation of the RDTF Community Reps and the challenges identified by Reps, which will proceed in early 2020. Citywide submitted to the review of the PPN handbook in relation to supporting Regional DATF Community Reps

#### Community Reps Resource Pack

Community Reps in all Task Force areas have received resource packs and relevant sections will be updated as required. We produced this information pack to provide DATF Community

#### Participate in the national structures of the National Drugs Strategy (RHSR)

Citywide has attended all meetings of the NOC & SCC. Meetings take place with the Regional Community Representative on a regular basis to support him in his role.

Citywide has attended all meetings of the DATF Handbook Working Group on behalf of the community sector overall, has circulated discussion documents to Community reps and met with Pavee Point, Uisce and NSFN to liaise with them in advance of the meetings. Also consulted with Voluntary sector Rep on a number of occasions



## **Community Drug Projects**

Community Drug Projects provide a range of services and supports to people who use drugs, their families and to the wider community. Citywide networks local Community Drugs Projects and Community Employment (CE) Drugs Rehab projects and represents the Community Sector at NDS policy committees.

Community Drug Projects, supported through Drug and Alcohol Task Forces (DATFs), have maintained a long and impressive tradition of responding to the needs of people experiencing drug-related harms. #### Drug Rehab Projects (DRPS) network

Two meetings were organised with the DRP IN 2019. Jim Walsh, Principal Officer, DPU attended the March meeting to meet with network members and hear their views about the upcoming IDG Review on Safeguarding the Future of Social Inclusion CE schemes.

Citywide submitted to the Interdepartmental Group in May 2019 after consultation with the DRP Network. As at the end of 2019 there has been no published outcome of the IDG Review.



## **Supporting Communities**

Citywide provides support to community and related groups in relation to planning, review, policy and related issues, as requested. During 2019 we met with the North East region FASN to support their strategic planning.

#### Black & Minority Ethnic Communities



Citywide, New Communities Partnership (NCP) and Cairde, along with Drug and Alcohol Task Forces and Pavee Point, presented the learning from our work to date on approaches to engaging with Black and minority ethnic communities in relation to the drugs issue.

The launch included presentations from Cork Local DATF and North Inner City Local DATF about how they went about making links to more effectively engage and communicate with Black and minority ethnic communities. There was a

musical performance from Waveculture, Creative Youth Group. <u>Report Here</u>

#### **Communities of Interest**

Citywide meets on an ongoing basis with BeLong To and other relevant LGBT groups to ensure that drug issues specific to this community are considered at all policy levels and support their engagement at the appropriate national/regional/local level in delivery of the NDS.

We work with Pavee Point Drug & Alcohol Programme and other Traveller representative groups to support them in addressing the Traveller drugs issue. Support their engagement at the appropriate national/regional/local level in the delivery of the NDS.

We work in partnership with the Family Support Network on relevant policy & campaign issues and in supporting participation of Family Support reps on DATFs. During 2019 we met with the NFSN regularly and participated in a Family Reps workshop at the NFSN annual conference.



## Increase general awareness and campaign on relevant issues

#### Crack Cocaine

In July we surveyed Community Drugs projects and DRPs about the level of crack cocaine use in their communities and by their clients

Feedback from our networks suggested an increase in the availability and use of crack cocaine in local communities in the past year. 84% of projects confirmed a rise in crack cocaine availability and use locally and 79% saw an increase in clients of their services using this drug. <u>Findings of the survey are available here</u>

#### Alcohol

Citywide worked with Alcohol Action Ireland to draw up a plan of action to support the speedy implementation of the Public Health (Alcohol) Act 2018.

We met with ICAAN (Irish Community Action on Alcohol Network), Alcohol Action Ireland and a number of DATFs on developing a joint plan for monitoring implementation of Public Health (Alcohol) Act. We briefed our networks on the implementation stages of the Public Health (Alcohol) Act and circulated a further briefing note on Sections 14, 17 and 20 of the Act.

#### Young People involved in the Drugs Trade



On April 30th Citywide launched '*The Drug Economy and Youth Interventions: An Explorative Research Project on working with Young People Involved in the Illegal Drugs Trade*' at an event in St Andrews Community Centre, Rialto.

Citywide commissioned this study to undertake some exploratory research with a small, yet intensely representative sample, of practitioners working directly with or encountering drug-related intimidation and violence in the communities in which they worked.

Dr Matt Bowden, Senior Lecturer at Technological University Dublin (TU Dublin) carried out the research in December 2017. The report presents the experience of those working in youth



services and community drug projects who are engaging with young people involved in, or at risk of becoming involved in, the illegal drugs trade.

Dr Fiona O'Reilly also presented a study conducted by herself, Lynn Ruane & Carol Murphy on the 'Perspective of Drug Dealers on Dealing'

Two projects working with young people who are involved in the drug economy and/or engaged in anti-social behaviours gave an outline of their work in this area.

- → *Ballymun Regional Youth Resource, Easy Street Project,* is an intervention model that is based on the Swedish Fryshuset model that builds on Community Relationships.
- → The TRY Project is part of the Donore Community Drugs & Alcohol Team in SIC. TRY targets young people and young adults engaged in anti-social behaviour and criminality which is having a serious impact on the quality of life of residents in local communities. TRY is described as an intensive outreach bridging model.

#### Open letter to the Taoiseach



Over 50 Community Drugs projects, Task Force Community Reps, Family Support & Service User groups have <u>signed a letter drafted by Citywide</u> calling for the Taoiseach to lead the government in accepting proposals for referral to health and support services and to draft the legislation needed to remove the criminal status of possession of drugs for personal use.

The Working Group on Alternative Approaches to criminalisation for possession of drugs for personal use have completed their report and a memo based on the recommendations of this report will shortly be brought to the Government. We are concerned at the indications that, while it will recommend a system for diversion to health services, which is very welcome, it will also recommend maintaining the criminal status) of possession of drugs for personal use. We know the huge impact having a criminal record can have on a person's life; it compounds the stigma experienced by people who use drugs and can negatively impact employment opportunities, training & education, future travel etc.



### Challenge drug-related stigma and its impact in our communities



Addiction is a health issue not a crime A template for a training programme on drugrelated stigma in partnership with the School of Nursing and Midwifery in Trinity College for delivery with professionals working with people who use drugs was developed during 2019 by Dr Michael Barron.

The programme will involve people with lived experience of drug use in its delivery. Ethical approval for this project has been granted by Trinity College. An application to IHREC under the grants scheme for funding to run the pilot has been approved. Discussions on the next phase of this programme continue with the SAOL Project and TCD.

#### Former Drugs Ministers call on Government to restore confidence in NDS



At an event organised by Citywide in October 2019 former Ministers for Drugs expressed concern and frustration at failure of Government to honour its commitments to work in partnership with community groups

All of the country's former Ministers of State with responsibility for the National Drugs Strategy have

united together to call on the Government to restore confidence in the National Drugs Strategy in particular because the partnership approach which underpins the Strategy is in danger of collapse. The <u>statement by the former Ministers is available here</u>

The statement was signed by all of the former Drugs Ministers between 1996 and 2016 including Pat Rabbitte, Chris Flood, Eoin Ryan, Noel Ahern, Pat Carey, John Curran TD, Róisín Shortall TD, Alex White and Senator Aodhán Ó Ríordáin.

# Working with Civil Society partners across Europe and internationally on development in drug policy and practice

- → We continue our representative role in the EU Civil Society Forum and relevant sub groups. We participated in the meeting of the EU Civil Society Forum on Drugs. Key items on the agenda were the evaluation of the current EU Drugs Strategy and discussion on perspectives for drug related policies after 2020.
- → Attended meeting on EU Drug Policy organised by the Civil Society Forum with MEPS on December 5th, the Irish reps (Citywide and ALDP) met with three of the Irish MEPs policy workers.
- → We continued to develop bilateral links with a number of our partner agencies from other countries on the Civil Society Forum and through the CSF UNGASS Working Group, International Harm Reduction Association (IHRA) and International Drug Policy Consortium (IDPC).
- Citywide was invited to present the findings of our report on the Drug Economy and Youth Interventions at the second meeting of the International Narcotics Control Board (INCB) with the Vienna NGO Committee on Drugs (VNGOC), on the topic of 'Young People and Drugs.' Representatives of civil society and the members of INCB discussed the importance of preventing drug abuse among young people and measures to reduce harms and treat drug use among youth. - Awarded an International Scholarship to attended the 2019 International Drug Policy Alliance Conference in St. Louis, Missouri, USA in November and participated in a range of workshops on key policy issues.
